2025 YORK COUNTY FAIR – July 31, August 1, 2 and 3**



To: Food Vendors

We are looking forward to having you be a part of the 2025 York County Fair. The theme this year is “All Signs Point to the York County Fair” and we expect to have a fun and successful fair. **Again this year the space rental will consist of ten percent (10%) of the gross sales at your booth for all food vendors. This year however, we are asking for a \$250 nonrefundable deposit to book your spot. At the end of the fair, we will deduct \$250 from your 10% sales owed.** We feel this keeps us in line with other fairs and events and helps reduce last minute cancellations. The space rental charge will include electricity furnished for booth lighting, fans, etc. **An extra charge will apply to RV’s or air conditioning units hooked into these outlets.** We will furnish outlets for each exhibitor who wishes to have electricity; however, you will need to bring your own heavy-duty extension cord to hook up to the outlets. **Please let us know your electrical needs before the Fair, to avoid delays at setup time.** The lot size is about 15’ x 20’, but may vary somewhat from one space to the next. Let us know any special needs.

This year’s Fair will start on Thursday, July 31, and end on Sunday, August 3, 2025. All exhibits will officially open at 12:00 noon on Thursday, and close at 2:00 p.m. on Sunday. All booths should be set up by Thursday by 11:00 am July 31, 2025, if possible. Commercial exhibits will open at 12:00 noon and close at 9:00 p.m. on Thursday and Friday, 10:00 am to 9 pm on Saturday and 12:00 noon to 2:00 p.m. on Sunday. You may continue operation as long as you see fit, as some evening events will last longer than 9:00 pm.

All Exhibitors’ cars and trucks not part of the exhibit must be parked in the main parking area west of the main Fairgrounds during the open hours of the Fair. Exhibitors are responsible for the contents in their booth.

A copy of the Space Rental Rules and Regulations is enclosed. Please read this, as it puts into writing what the rules are on the fairgrounds. Again for 2025 because of requirements of the Nebraska Department of Revenue, Commercial Vendors are asked to put their NE Sales Tax ID Number on the Application. All Vendors are also asked to submit proof of LIABILITY INSURANCE BINDER/COVERAGE with your Booth Rental Application. As in years past, the State of Nebraska Food Inspectors may be on the grounds at any time to inspect food booths. Please cooperate with them.

For those of you who were here, we will reserve the same space at the 2025 Fair that you occupied at the 2024 Fair for you whenever possible, as long as reservations are made in a timely manner. Requests for changes may be made, but will be granted only where possible. Please fill out and return the following if you wish a space reserved this year.

Reservations must be made by June 30! If you do not plan to attend, please let us know.

We would like to reserve space for our Food Stand at the 2025 York County Fair. I/We agree to provide total sales numbers to the York County Agricultural Society for determination of space rental charges, as well as provide proof of Liability Insurance coverage. This entitles us to a minimum space of 15’ x 20’.
